#### REPORT OF THE INDEPENDENT ACCOUNTANT

To the management of Amazon Trust Services, LLC ("ATS"),

We have examined ATS management's <u>assertion</u> that for its Certification Authority ("CA") operations in various location in the United States of America, throughout the period January 16, 2019 to January 15, 2020 for its CAs enumerated in <u>Attachment B</u> in scope for SSL Baseline Requirements and Network Security Requirements, ATS has:

- disclosed its SSL certificate lifecycle management business practices in the applicable versions of its Certification Practice Statement and Certificate Policy enumerated in <u>Attachment A</u>, including its commitment to provide SSL certificates in conformity with the CA/Browser Forum Requirements on the ATS <u>repository</u>, and provided such services in accordance with its disclosed practices
- maintained effective controls to provide reasonable assurance that:
  - the integrity of keys and SSL certificates it manages is established and protected throughout their lifecycles; and
  - SSL subscriber information is properly authenticated
- maintained effective controls to provide reasonable assurance that:
  - logical and physical access to CA systems and data is restricted to authorized individuals;
  - o the continuity of key and certificate management operations is maintained; and
  - CA systems development, maintenance, and operations are properly authorized and performed to maintain CA systems integrity
- maintained effective controls to provide reasonable assurance that it meets the Network and Certificate System Security Requirements as set forth by the CA/Browser Forum

based on the WebTrust Principles and Criteria for Certification Authorities - SSL Baseline with Network Security v2.3. ATS' management is responsible for its assertion. Our responsibility is to express an opinion on management's assertion based on our examination.

The relative effectiveness and significance of specific controls at ATS and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls, and other factors present at individual subscriber and relying party locations. Our examination did not extend to controls at individual subscriber and relying party locations and we have not evaluated the effectiveness of such controls.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether management's assertion is fairly stated, in all material respects. An examination involves performing procedures to obtain



evidence about management's assertion. The nature, timing, and extent of the procedures selected depend on our judgment, including an assessment of the risks of material misstatement of management's assertion, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

Because of the nature and inherent limitations of controls, ATS' ability to meet the aforementioned criteria may be affected. For example, controls may not prevent, or detect and correct, error, fraud, unauthorized access to systems and information, or failure to comply with internal and external policies or requirements. Also, the projection of any conclusions based on our findings to future periods is subject to the risk that changes may alter the validity of such conclusions.

In our opinion management's assertion, as referred to above, is fairly stated, in all material respects.

Without modifying our opinion, we noted the following other matters during our procedures:

	Matter Topic	Matter Description
1	Certificate Content	ATS disclosed in Mozilla Bug 1525710 five (5) certificates were issued with a validity period set for 39 months, which exceeds the 825 day limit in the Baseline Requirements. Additionally, the issued certificates contained Subject Distinguished Name ("Subject DN") attributes that were explicitly not allowed based on the policy identifier included in the certificate.
		ATS disclosed in Mozilla Bug 1574594 three (3) certificates were issued without a Subject Alternative Name field present.
2	Certificate Content and Revocation	ATS disclosed in Mozilla Bug 1569266 five (5) certificates were issued with no space between "Private" and "Organization" in the Subject DN. Additionally, the time period between completion of investigation and revocation of the mis-issued certificates exceeded the five (5) day timeframe permitted by the Baseline Requirements.
3	Human Log Review	Log content and integrity was reviewed when offline systems were accessed. Human reviews of application and system logs to validate the retention and integrity of offline logs were not being performed on a monthly basis during the examination period.

This report does not include any representation as to the quality of ATS' services other than is CA operations in various locations in the United States of America, nor the suitability of any of ATS' services for any customer's intended purpose.
